- 3. **Executive Director's Report:** Paul Berg reported that the center is doing well and becoming busier. Paul is working with Ken, the board's attorney, to set up a sunshine meeting either in person or online.
- **4. Finance Update:** Alan Preston reported that the center has cash in the bank. The bottom line is far better that was forecasted. The finance committee did not meet last month.
- 5. New Business: Bill DeMare asked the board when the center should start having in person meetings. Alan said that we could continue with on line meetings since it is free with Google. Bill asked board members to state if they were vaccinated because Susan had some concerns. Bill stated that we could continue on with a quorum in person and using zoom and meeting at 12:00 until we discuss it again in the summer.
